Consultation Survey on Program-Level Fellowship Pool

This is a student consultation for the 2023/2024 Faculty of Arts and Science Program-Level Fellowship. This was implemented to support graduate research and education priorities. Each department has the opportunity to consult with its graduate students to identify the most beneficial way to use this resource. The fellowship will be scaled to the number of students in the funded cohort (calculated at \$1000 per student in 2023-24). These funds can only be distributed directly to students in the funded cohort, and will not require additional TA or RA work.

The Graduate Department of Chemistry requests your input on how to best utilize this funding for the academic year 2023-2024. If you wish to speak to the Associate Chair about your recommendations, please contact Professor Mark Taylor at chem.gradchair@utoronto.ca to set-up a meeting.

PLF distribution since implementation:

- In 2017/2018, PLF was distributed as follows: \$400 towards increasing base funding; \$100 towards funding financial need especially for those who do not quality for OSOTF.
- In 2018/2019, PLF was distributed as follows: \$900 towards increasing base funding' \$100 towards funding financial need especially for those who do not quality for OSOTF.
- In 2019/2020, PLF is being distributed as follows: \$700 towards increasing base funding (will be paid out in late November/early December); \$200 towards teaching reduction awards to 10 doctoral students in their 3rd year and beyond; \$100 towards financial assistance especially for those who have dependents and/or do not quality for OSOTF.
- In 2020/2021, PLF is being distributed as follows: \$700 towards increasing base funding (will be paid out in late November/early December); \$200 towards teaching reduction awards to 10 doctoral students in their 3rd year and beyond; \$100 towards financial assistance especially for those who have dependents and/or do not quality for OSOTF.
- In 2021/2022, PLF will be distributed as follows: \$700 towards increasing base funding (will be paid out in December); \$200 towards teaching reduction awards to 10 doctoral students in their 3rd year and beyond; \$50 towards financial assistance especially for those who have dependents and/or do not quality for OSOTF. \$50 towards creating awards for achieving milestones in the program.
- In 2022/2023, PLF will be distributed as follows: \$900 towards increasing base funding (will be paid out in December to all students in the funded cohort including major scholarship holders) and \$100 towards financial assistance especially for those who have dependents and/or do not quality for OSOTF.


Current take-home pay (ie. after fees) in chemistry is \$26,900 (no major scholarship), \$29,170 (OGS/QEII), \$30,359 (CGS M/PGSD) and \$35,080 (CGSD). In addition, students in the funded cohort (including scholarship holders) are also scheduled to receive an additional \$500 from the Faculty of Arts & Science. The objective of the Program Level Fellowships is not just to provide funds to students, but to have a conversation about funding in a respectful way.




Current Program of Study



Do you support the current PLF plan for the AY 2022-23? 49 responses






Constructive Comment(s), if any:6 responses

- Unclear whether the \$900 will also go to award holders (OGS and NSERC). I believe there should be a \$900 increase for all.
- Even with multiple scholarship opportunities, base funding remains to be the most important factor to me for calculating future expenses, without having to rely on the chance (and not guarantee) of receiving a scholarship.
- This should include students with funding as well (CGS, NSERC ect.) because we get zero dollars from the department just because we got an award. This doesn't encourage students to apply for this awards because we end up getting the same amount of funding (compared to students with no awards) after paying our tuition.
- we're living below the minimum wage, this should be a priority
- Cost of living keeps going up, but student funding does not match that rate of increase.
- Rent is ~\$1500-~\$2000 for a bachelorette/bachelor in Toronto; if students only earn ~\$2000/month, this leaves very little money (if any) for living expenses. This prevents students form really saving any money, which is essential for when funding is cut prior to program completion for students writing their thesis, and after they defend their thesis but before they can find a job. Therefore, I believe there should be great emphasis placed on increasing the base funding for students who are forced to rent in Toronto and aren't fortunate enough to be able to commute. I argue this issue should be remedied through an increase in the base funding for students forced to rent, and not through financial aid programs such as OSOTF, because these programs are: 1) difficult to find/access, and 2) have extremely complicated and confusing application processes. Additionally, I believe these students who are struggling financially shouldn't have to bend over backwards to access financial aid that they are in need of, and that I believe the school owes them.

For 2023-24, continue the support for students in particular financial need (eg. with dependent children, study permit holders and those ineligible for OSOTF).
